

THE TINECO TINECOPRIME GIVEAWAY RULES
NO PURCHASE NECESSARY. VOID WHERE PROHIBITED.

1. **SWEEPSTAKES:** The Tineco Giveaway (the “**Sweepstakes**”) begins at 6:00 a.m. Pacific Standard Time (“**PST**”) on July 6, 2023 and ends at 11:59 p.m. Pacific Standard Time (“**PST**”) on August 6, 2023 (the “**Sweepstakes Period**”). Participation is free of charge. There is no purchase or payment of any kind necessary to participate in the Sweepstakes. A purchase does not improve your chance of winning.
2. **ELIGIBILITY:** Open to legal residents of United States, Canada, Germany and France, 18 years of age or older as of date of entry (“**Entrant**”). Employees of [Intelligent Technology Co., Ltd.] (“**Sponsor**”), and its parents, subsidiaries, divisions, affiliates, suppliers, distributors and advertising, promotional and judging agencies and their respective officers, directors, shareholders, members, employees, agents, assigns, and all others associated with the development, evolution and execution of this Sweepstakes (collectively “**Sponsor and its Administrators**”) and the immediate family members of each, are not eligible to participate or win.
